RE: Principal's Attestation Title I, Part A Programs Regarding Staff Qualifications

"No Child Left Behind" requires principals to attest yearly as to their school's compliance with Section 1119. Section 1119 identifies teacher and paraprofessional qualifications:

- **New hired teachers:** All teachers assigned to schools after the first day of the 2002-2003 school year and teaching in a program supported with Title I, Part A funds are "highly-qualified," as defined by the Mississippi Department of Education, Office of Educator Licensure.
- **Existing teachers:** All teachers assigned to schools on or before the first day of the 2002-2003 are highly qualified, as defined by the Mississippi Department of Education, Office of Educator Licensure.
- **Newly hired paraprofessionals:** Title I paraprofessionals hired after January 8, 2002, must have one of three qualifications:
 - Passing Score ACT WorkKeys assessment
 - 48 credit hours with a minimum C grade
 - An associate's degree or higher
- **Existing paraprofessionals:** By January 8, 2006, paraprofessionals hired on or before January 8, 2002, must meet the standards for new paraprofessionals.
- **All paraprofessionals:** Effective immediately, all Title I paraprofessionals, regardless of hire date, must have a high school diploma or a recognized equivalent.
- **Paraprofessional duties:** Title I paraprofessionals may not perform classroom instruction unless supervised by a highly qualified teacher and may not perform more non-educational duties than non-Title I paraprofessionals. Paraprofessionals with instructional duties and working in a program supported with Title I, Part A funds, are assigned to (1) provided one-to-one tutoring for eligible students, if tutoring is scheduled at a time when a student would not otherwise receive instruction from a teacher; (2) assist with classroom management, such as organizing instructional and other materials; (3) provide assistance in a computer laboratory; (4) conduct parent involvement activities; (5) provide support in a library or media center, (6) act as a translator; or (7) provide instructional services to students in accordance with statute. All paraprofessionals in Title I, Part A programs work under the direct supervision of a teacher to provide instructional services to students following these guidelines: (1) the teacher plans the instructional activities; (2) the teacher evaluates the achievement of the students; and (3) the paraprofessional works in close and frequent physical proximity to the teacher.
